## Rules & Regulations

1. Booths: No subletting of booth space – only one company/organization can occupy or advertise in each booth.  
**Rental of booth is \$100.00 for 8ft. table with linens, (no skirting).**
2. **Setup Times: 9am at the Frazee Event Center Sunday, February 28<sup>th</sup>, 2010. You must be set-up by 11:30am.**
3. Only products relating to your specific business may be displayed/sold from your booth. On-site food is available for taste testing only. On site food sales are allowed provided the product is packaged for gift or take-home purchases, not for personal consumption while at the wedding expo. Any vendor selling products must do so in accordance with MN Department of Health and the MN State tax laws. All sales and taxes are the responsibility of the vendor.
4. **Booths sold on a first-come, first serve basis.** Get your reservation and payment in right away!
5. **Each vendor is required to donate an item valued at a minimum of \$100.00 to be given away as part of the “Grand Prize” package to one couple.** Drawing will be held at the end of the Wedding Expo.
6. Vendors are permitted to give away an additional door prize if desired. All drawings for door prizes must be drawn at the end of the Enchanting Event Wedding Expo. Delivery of door prizes is the vendor’s responsibility.
7. Vendors will be required to keep their booth displays neat and orderly throughout the show. If a vendor displays any item that would require additional clean-up, the vendor is responsible to keep their area clear of debris.
8. Nothing shall be removed from your booth before the close of the Wedding Expo at 4pm. All booths are to be taken down and removed following the Wedding Expo closing by 6pm. No Exceptions. Violators will not be permitted in future shows.
9. **Payment must accompany reservation form. No space is guaranteed until payment is received in full.**
10. **Cancellations:** All cancellations will incur a \$25 service fee. No refunds given on cancellations 2 weeks prior to the Wedding Expo date.
11. **Waiver of Liability:** The Wedding Expo shall not be responsible for any personal injuries, for loss of damage to vendor’s property or for any damage done to the building by vendors, their agents, or employees. All property destroyed or damaged by the vendors must be replaced in its original condition or at the vendor’s expense. Walls, woodwork, doors and floors of the Frazee Event Center must not be defaced or altered in any manner whatsoever. Vendors must also follow any guidelines set forth by the Frazee Event Center, where the Wedding Expo is held.
12. **Insurance:** It is the responsibility of each Vendor to maintain insurance coverage against injury to persons or damage to or loss of property or to meet its obligations under this agreement, in such amounts as the vendor deems adequate.
13. **Rights:** The Wedding Expo staff reserves the right to refuse any vendor, exhibit, or employee which, in their opinion is not in the best interest of the show. The Wedding Expo staff also reserves the right to approve all vendors and to make booth location changes to best serve the show as a whole.
14. **Violations:** Vendors shall be bound by the rules and regulations set forth herein, and by additional rules and regulations which may be established by the Wedding Expo staff. Any violations by a vendor of any terms or conditions herein shall be subject to the cancellations of the contract to occupy exhibit space, and forfeiture of any monies paid on account thereof upon due notice of such cancellation. The Wedding Expo staff shall have the right to take possession of Vendor’s space, remove all persons and properties of vendor, and hold vendor responsible for risks and expenses incurred in such an event. All matters and questions not covered by the above will be subject to final judgment and decision by the Wedding Expo Staff.
